License Agreement - Read Before Buying or Using Product(s)

Licensee:

This License Agreement is a legal agreement between Licensor and Licensee for the use of the fully 2257 compliant content purchased from Ace Adult Content.

Grant of License, General Terms

Licensor owns and distributes the Product or products purchased by the licensee. In accordance with this agreement, Licensor grants Licensee a non-exclusive license to distribute images and videos on their website(s), in print or other digital or physical media. Licensor retains titles and ownership of the Product, and gives up no legal rights as part of this agreement.

Licensor represents and warrants that Licensor owns all rights granted herein to the content set out on Schedule "A" hereto (the "Content"). Licensor grants Licensee a non-exclusive license to distribute the Content on Licensee Sites including distribution to ipod type and wireless telephony devices and print or other physical or digital media as specified below. Licensor retains title and ownership of the Content.

Licensee agrees not to sell or distribute the images or videos to other webmasters or businesses other than as affiliate content or in free hosted galleries. Licensee acknowledges that unauthorized reproduction of copies of the licensed material may constitute a serious crime, and that such actions may also result in a suit for damages, injunctive relief, and attorney fees, pursuant to this agreement and to other rights that the licensor may have. Acceptable Uses of Licensed Content

Unacceptable Uses of Licensed Content

Revocation of License
